- 1 Remove the plant closest to the pavement which is over hanging the pavement, obscuring the street light and adversely affecting the health of the hedge beneath.
- 2 Prune the middle plant to cut canopy back so it does not overhang the hedge. The hedge is currently stressed by lack of water and light.

Pittosporum hedge at boundary with the pavement (see photos and sketch plan)

- 1 Reduce to previous height of 1m to allow sunlight into the flower bed behind and encourage growth of plants.
