T1 Lilac sp. - Height 6m, Multi stem - Mostly dead, growing between other shrubs - Fell lilac (check bird's nest)

T2 Prunus 'Kanzan' Cherry) - Height 10m, Diameter 60cm - Cavity at base extends 20cm into trunk, 2m from building, close to wall, cracks observed in building and wall - Fell and treat stump.

T3 Prunus sp. (Cherry) - Height 5m, Diameter 25cm - Close to building and front wall, subsidence issues - Fell

T4 Prunus sp. (Cherry) - Height 3m, Diameter 2 x <10cm - Too close to building (4m) - Fell

T5 Prunus sp. (Cherry) - Height 4m, Diameter 3 x <10cm - Too close to building (2m) - Fell

T6 Sorbus aucuparia (Rowan) - Height 8m, Diameter 20cm - Only 5m from building - Fell (consent already granted?)

T7 Betula pendula (Silver Birch) - Height13m, Diameter 40cm - Good condition - Raise crown to 4m, remove deadwood, prune back to glass wall

T8 Betula pendula (Silver Birch) - Height 10m, Diameter 15cm - Good condition - Remove deadwood

T9-13 & T15 - Robinia pseudoacacia - Various heights and diameters - Overhangs boundary, some dead branches - Raise crowns to 6m above pavement level, cut back overhang from Spring Grove, prune out major deadwood

14 Robinia pseudoacacia - Height 13m, Diameter 2 x 15cm - Overhangs Spring Grove, close to boundary wall - Fell

T22 Fraxinus excelsior (Ash) - Height 13m, Diameter 17cm - 1m from boundary wall, touches roof of Spring Grove - Fell to 1.5m to retain insect hotel

T23 Robinia pseudoacacia - Covered with ivy - Fell minor stem, trim ivy back to trunk

T29 Tilia sp. (Lime) - Height 18m, Diameter 22m - Choked with ivy, dead - Fell

T35 Tilia sp. (Lime) - Close to building - Crown reduce by 30%

T36 Salix caprea (Goat Willow) - Height 15m, Diameter 30cm - <1m from building, high water demand - Fell

T37 Prunus sp. (Plum) - Cut back to clear building by 1m
