Willow T1 (12M high, 500mm dia.) - Reduce the crown of the tree back to the most recent points of reduction (6 metres)

Rowan T2 (10M high, 300mm dia.) - Reduce the crown of the tree back to the most recent points of reduction (2 metres)

Ash T3 (10M high, 300mm dia.) - Reduce the crown of the tree back to the most recent points of reduction (3 metres)

Raywood Ash T4 (12M high, 450mm dia.) - Reduce the crown of the tree by up to 2.5 metres

Sweet Gum T5 (12M high, 250mm dia.) - remove 3 lowest branches (50mm dia.) to raise crown of the tree.
