Insertion of 5 conservation type rooflights to rear and side roofslopes.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless

otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017 and policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018.

The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan; (23THU-)100 rev 0, 102 rev 0 to 110 rev 0 (inclusive), 111 rev 1, 112 rev 1, 113 rev 0, 114 rev 0.

Reason:

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reason for granting planning permission:

The proposed conservation style rooflights would be suitably recessed within the side and rear roofslopes, sitting flush with the roof tiles so as not to project above the roof plane. The rooflights would be generally small in scale and appear subordinate on the roofslope, and as such, would not be widely noticeable, especially given their proposed positions at the side and rear. The largest rooflight in particular is on a slope facing inwards towards the middle of the roof and would be well screened in this location, so reducing any visual impact. The proposed rooflight on the side roofslope would also benefit from screening provided by a chimney breast behind which it would be positioned.

As a consequence, the proposal is considered to be in keeping with the overall appearance of the host property in terms of its' design, proportions, location, colour and materials used, and would preserve the character and appearance of the building and wider Fitzjohns Netherhall Conservation and Hampstead Neighbourhood Areas, and is acceptable.

There are no amenity concerns as a result of the proposal given the minor nature of the alterations at the side and rear of the property.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Fitzjohns Netherhall Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposal is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017, policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018, the London Plan 2021 and the National Planning Policy Framework 2021.
