### **DECISION**

# Certificate of Lawfulness (Proposed) Granted

The Council hereby certifies that the development described in the First Schedule below, on the land specified in the Second Schedule below, would be lawful within the meaning of Section 192 of the Town and Country Planning Act 1990 as amended.

#### First Schedule:

Certificate of lawful development for proposed erection of a rear dormer extension and installation of two front rooflights, and installation of a rainwater pipe.

Drawing Nos: 1108 (00) 00; 1108 (01) 01A; and 1108 (01) 02A.

## Reason for the Decision:

- 1 The proposed rear roof extension is permitted under Class B Part 1 Schedule 2 of the Town and Country Planning (General Permitted Development) England Order 2015.
- The rooflights in the front roof slope are permitted under Class C of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.
- 3 The rainwater pipe shown on the rear roof extension is permited under Class G

of Part 1, Schedule 2 of the Town and Country Planning (General Permitted Development) (England) Order 2015.

- You are advised that this development would only constitute permitted development if the total volume of the proposed extensions does not exceed 40 cubic metres, in accordance with B.1(d) of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).
- The development would only constitute permitted development if the materials used in any exterior work to the rear roof extension subject to the grant of this certificate, shall be of similar appearance to those used in the construction of the exterior of the existing dwelling house, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015.
- The development subject to the grant of this certificate, would only constitute permitted development where the edge of the enlargement closest to the eaves of the original roof shall, so far as practicable, be not less than 20 cm from the eaves of the original roof, in accordance with Condition B.2 of the Town & Country Planning (General Permitted Development) Order 2015
- The development subject to the grant of this certificate would only constitute permitted development where the roof lights would project no more than 150mm beyond the plane of the roof slope, in accordance with Condition C.1(b) of the Town & Country Planning (General Permitted Development) Order 2015.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Judd St, Kings Cross, London NW1 2QS (tel: 020-7974 6941).
- This approval does not authorise the use of the public highway. Any requirement to use the public highway, such as for hoardings, temporary road closures and suspension of parking bays, will be subject to approval of relevant licence from the Council's Streetworks Authorisations & Compliance Team, 5 Pancras Square c/o Town Hall, Judd Street London WC1H 9JE (Tel. No 020 7974 4444). Licences and authorisations need to be sought in advance of proposed works. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
