Details in respect of condition 3 of planning permission 2018/0910/P, as amended.

We write on behalf of our client, SLQR Trustee No.1 Limited and SLQR Trustee No.2 Limited as co-trustees of SLQR Unit Trust No.1, in respect of the above planning permission. This application seeks approval for those details reserved by Condition 3 (parts A and E) only.

Condition 3 reads:

“Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:

a) Typical details of new railings at a scale of 1:10 with finials at 1:1, including materials, finish and method of fixing into the plinth.

b) Plan, elevation and section drawings, including jambs, head and cill, of all external new window and door openings.

c) Samples and manufacturer's details of all new facing materials including glazing.

d) A sample panel of all final facing material shall be erected on-site and approved by the Council before the relevant parts of the work are commenced and the development shall be carried out in accordance with the approval given. The panel must be constructed at 1:1 scale and be no less than 1m2 in size demonstrate the proposed colour, texture, mesh size, fold and surface joints of the facing material.

e) Plan section and elevation details of the new shopfronts.

f) Plan, elevation and section drawings showing the typical façade details including expansion joints; panel divisions; parapet; party wall upstand; roof
