- T2) Beech x 2 - 82 Fairhazel Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T3) Lime x 1 - 24 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T4) Lime x 2 - 22 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T5) Lime x 2 - 18 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T6) Lime x3 - 16 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T7) Sycamore x 1 - 14 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T8) Small Oak x 1 (growing underneath big ash tree) 38 Canfield Gardens - Reduce crown by 25% 1.5m off height 1.5m off width
- T9) Lime x 2 - 51 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T10) Lime x 1 - 49 Canfield Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points
- T11) Sycamore - 62 Greencroft Gardens - Reduce crown by 25% 2.5m off height 2m off width back to previous growth points

All trees stated above will be located directly in the front garden of all properties (named above). Trees are mature and very easily located using google maps.
