Assessment

The s.211 notification is for the removal of a willow tree from the frontage of University College School which is situated within the Redington Frognal Conservation Area. The application alleges that the tree is poor condition.

The 9m mature willow tree is highly visible from the public realm and contributes to the character and appearance of the conservation area. The tree has been heavily pruned historically and has been maintained by repeated crown reduction. The tree is adjacent to a vehicular and pedestrian entrance and is leaning towards the highway. If the tree were to fail it would reach the highway and/or the entrance.

The tree is host to *Phellinus igniarius*, a fungal organism which causes white rot and is common on willow trees. The arboricultural report submitted with notification describes the condition of the tree, its location and the significance of the fungal organism. The report does not however quantify the extent of the decay, as such the council requested that the agent provide further evidence to justify the removal of the tree. A resistograph investigation was undertaken and a report submitted. The findings of the investigation are considered sufficient to demonstrate that the decay is extensive and the structural integrity of the tree is compromised.

Given the use of the site, the position of the tree within the site and condition of the tree its removal is considered justified.

The council has no powers to add conditions of any kind relating to replacement planning or otherwise when determining s.211 notifications. The council has been assured that the tree will be replaced which is welcomed but as this cannot be conditioned it has not formed part of the justification for decision.

The council does not object to the proposed works.
