The noise is likely to be substantial and will be even more of a nuisance to local residents if application no. 2021/3006/P for extended opening times is granted.</p> <p>~~~~~</p> <p>Application 2021/3006/P</p> <p>This application will increase the nuisance to local residents particularly from air conditioning units which will be functioning for longer hours, bearing in mind 1. the retrospective planning permission already granted for existing units and 2. application no. 2021/2861/P for a substantial number of new units which doesn't include any protection against sound.</p>

It appears to be a substantial proposal, and contravenes the fact that Glenhurst Avenue is a CONSERVATION AREA. This could be the thin end of the wedge. The proposal for a 1.8 meter steel louvre barrier would adversely affect the outlook of all houses on the Southern side of Glenhurst Avenue and would not offer protection against sound coming from the proposed substantial number of units. This sound is likely to be considerable and would be even more of a noise nuisance to local residents if application no. 2021/3006/P for extended opening times is granted.</p> <p>I strongly object to this application. It would create both noise and air pollution - especially incongruous at a time when we are mindful of the vagaries of global warming.</p>

2021/2861/P	Linda Bourn	30/08/2021 14:54:06	OBJ	<p>The environmental impact of air conditioning is well known-it accounts for 10% of the world's energy consumption.</p> <p>Camden's planning guidance document 'Energy efficiency and adaptation' contains many suggestions for preventing overheating and minimising the energy consumption of a building. It does not appear that Spectrum House has put any of these into practice in their recent refurbishments.</p> <p>The planned screen is visible to residents in Glenhurst Avenue. Nothing in the design mitigates the industrial appearance (eg green walls).</p> <p>The screen would be unnecessary if Spectrum house had heeded Camden's advice. There has been no consideration given to energy consumption.</p> <p>Doubts were cast on the reliability of noise level measurements. These were expressed previously in the withdrawn application 2020/2612/P</p>
