T1: Hornbeam: Front garden: Reduce back to previous and most recent reduction points. General maintenance.

T2: Multi stemmed Birch: Rear garden: Thin crown density throughout by 20%. Remove dead wood. Reduce extraneous branches back into main crown structure. General maintenance.

T3: Birch: Right hand boundary: Thin crown density throughout by 20%. Reduce crown by 20%. General maintenance.

T4: Elder: Left hand boundary: Reduce overhang by approximately 30% (1.50m). Thin crown density of overhanging section by 20%. Overhanging from No. 48 Downshire Hill.

T5: Portuguese laurel: left hand boundary: Reduce back to as near to the boundary (approximately 1.00-1.50m). Overhangs from No.47.

T6: Ash: Left hand Boundary: Reduce overhang back to as near to the boundary as practicable. Overhangs within the curtilage of No.47.
