They are unsightly and over time plant units of this type become more noisy. We overlook the wall that they have been installed on. 2. Camden council should not sanction the oversailing of council (or publically) owned land. By allowing this aspect of the application Camden will over time give a private land owner rights of access over public land. This is not in the public interest and may stymie later plans from Camden council.</p> <p>I also wish to complain about the lighting from Spectrum House courtyard which is often on all night. It is very high lux and is inappropriate as the housing on the boundary is residential and the bedrooms look onto Spectrum House. The light is keeping me and my daughter awake. It is white light and very bright in our bedrooms. They should have a warmer coloured light which is low level and low lux and only on when needed. At the moment it is like backing onto a supermarket car park. Both the external facing plant and the lighting degrade the character and amenity of the conservation area.</p>

It is land theft and should not be allowed.</p> <p>I also want to add my objection to the bright white light now emitted from Spectrum House courtyard. A lighting scheme has been installed which has high levels of light and the light colour is white. Two of my bedrooms receive excessive light at night now and it can be difficult to sleep. Not only is it affecting sleep patterns as it has regularly been on late at night or all night but it is light pollution of the worst kind close to Hampstead Heath. A warmer coloured light source with low lux levels would be much more suitable cheek by jowel with the rears of many residences whose bedrooms overlook Spectrum house.</p>
