T3: (front garden) Holly: Reduce height by 1 metre and reshape.

T4: (rear garden) Extra large Lime: reduce height by 4 metres and sides by 2.5 metres to allow more light into the garden.

T5: (rear garden) Extra large Maple- TPO: Remove central stem with cavity and reduce remainder by 2 metres circa.

T6: (rear garden) Lime x 6: Re pollard
