There has also been a conversion done about a meter or so away from the tree. This may have destabilised the tree if any of the roots were cut. We would need to get a decision made on this quickly and for one of the tree officers to go and see it ASAP as if this tree falls down, it will cause considerable damage to all the gardens in its vicinity.
