NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

IN GROUNDS RIGHT SIDE: 1 x Silver Birch (T14) - Fell to ground level.

3 x Silver Birch (T15, T16 & T18) - Reduce heights by 2.5m and widths by 1m - 1.5m.

1 x Bay Tree (T27) - Reduce height by 1.5m - 2m.

ENTRANCE GLENLOCH ROAD: 1 x Silver Birch (T21)) - Reduce side facing building by 1.5m and crown lift to 4m.

FRONT GARDEN: 1 x Oak (T44) - Fell to ground level.

1 x Sycamore (T58) - Reduce height by 3.5m and width by 2.5m all around and thin crown by 20%.

1 x Sycamore (T59) - Reduce crown back to previous points of reduction, (8m off height and 3m off width).

FRONT PARKING AREA: 1 x Pear (T61) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 28 July 2021 and does not wish to object.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
