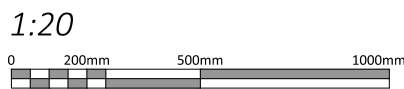




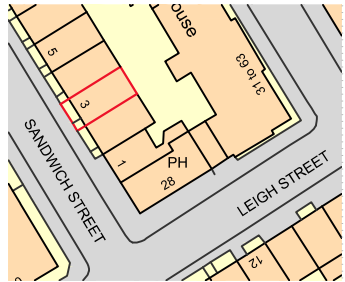
Ground Floor
