T7 - Sycamore - Located Regent Park Road side - Close to neighbour, regular pollard - Would like to re-pollard to previous pruning points removing up to 2m
G1 - Birch x 3 - Located Fitzroy Road side - Low over footpath - Would like to crown lift to approx 2.5m
T8 - Oak - Located to rear of property - Deadwood in crown - Would like to remove deadwood
T10 - Maple - Located to rear of property - Deadwood in crown - Would like to remove deadwood
These works are all for maintenance purposes.
