NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Ash (*Fraxinus excelsior*) (T1) - Reduce to match the height of previous points retaining 4m above ground level. Reduce side branches to match, shape, balance, and tidy.

1 x Plum (*Prunus*) (T2) - Reduce entire crown by 25% to suitable growth points. Reduce lateral branches to match. Thin by 15% to allow more air/light through canopy.

1 x Monterey Cypress (*Cupressus macrocarpa*) (T3) - Fell to ground level.

FRONT GARDEN: 1 x Holm Oak (*Quercus ilex*) (T4) - Reduce crown height to match neighbouring tree retain 3m above ground level. Light trim all sides to shape and tidy.

The Council has considered your notification of intended works to trees dated 30 July 2021 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS

3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
