T1: Ash: To Reduce the tree back to the most recent reduction points whilst preserving a suitable amount of furnishing growth.  
T2 & T3: To reduce back to the most recent reduction points, remove the heavy epicormic shoot regrowth and remove dead wood  
T4: Beech: To thin the crown density by 25%, to remove all dead wood and remove extraneous branches back to the main crown structure  
T5: Hawthorn: To thin the crown density by 15% to improve light filtration

All works are being carried out to maintain the trees at a suitable size for their urban location whilst also trying to maintain a natural and attractive appearance.
