# INTRODUCTION

## PROPOSED RELOCATION OF PV PANELS

This application seeks approval for a minor relocation of 4no. PV panels at 22 Frognal Way development. PV locations have been previously approved (application ref: 2019/0564/P) and an approved roof plan (ref: FGW-P-110 revA) is included alongside a proposed roof plan (ref: FGW-P-110 revB).

Following a detailed design by a Specialist, we were advised that 4no. PV panels would need to be relocated in order to ensure their performance/efficiency and coordination with other services.

It is proposed to relocate these 4no. PV panels from a southern roof onto a north-western roof while maintaining a current number of panels as previously approved (2019/0564/P).

The proposed new roof location benefits from a higher parapet which will visually shield the relocated PVs from view. Furthermore, this roof already houses several PV panels as per the approved roof plan and the proposed relocation of 4no. PVs would not affect the overall appearance of the development.

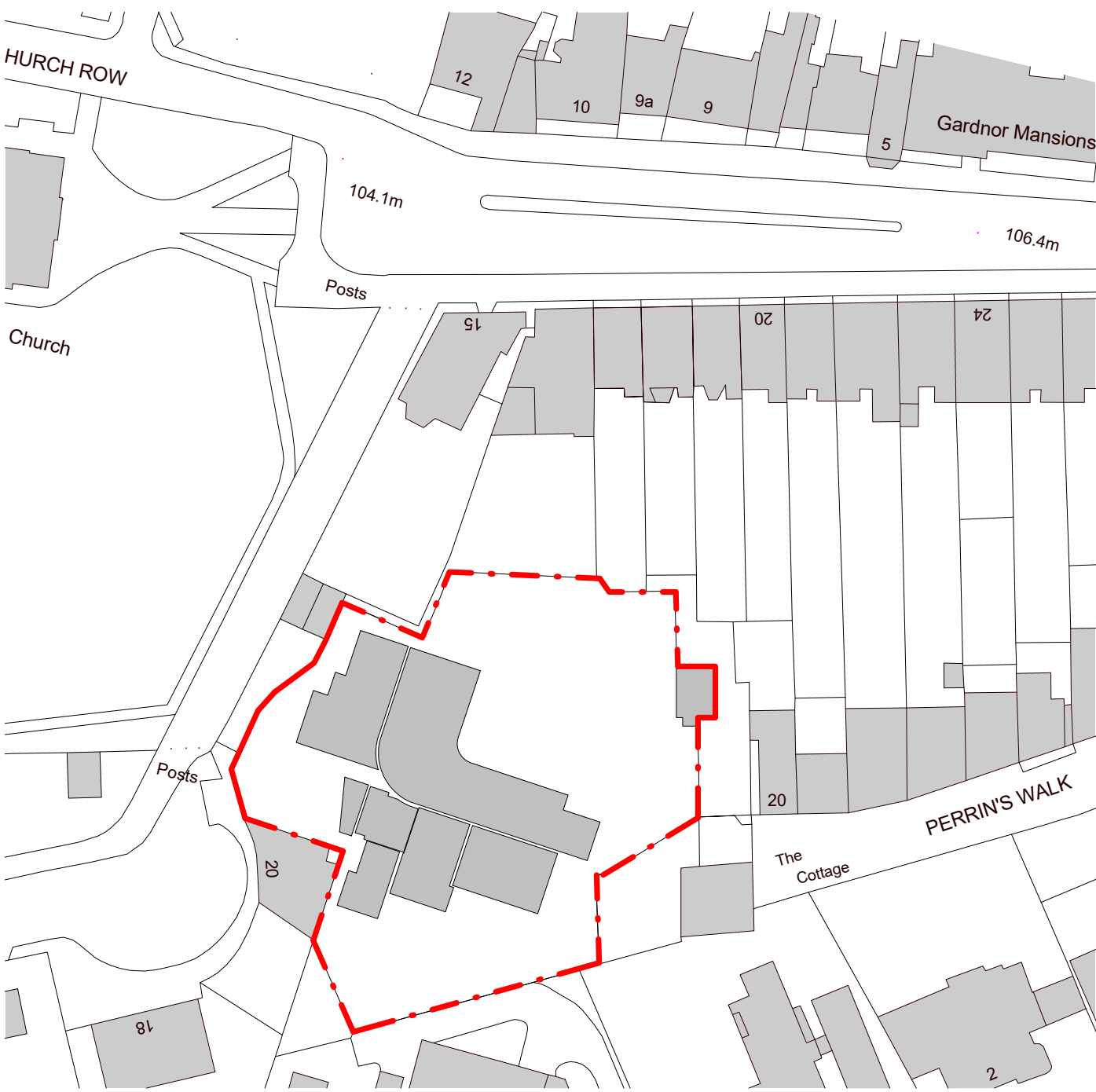

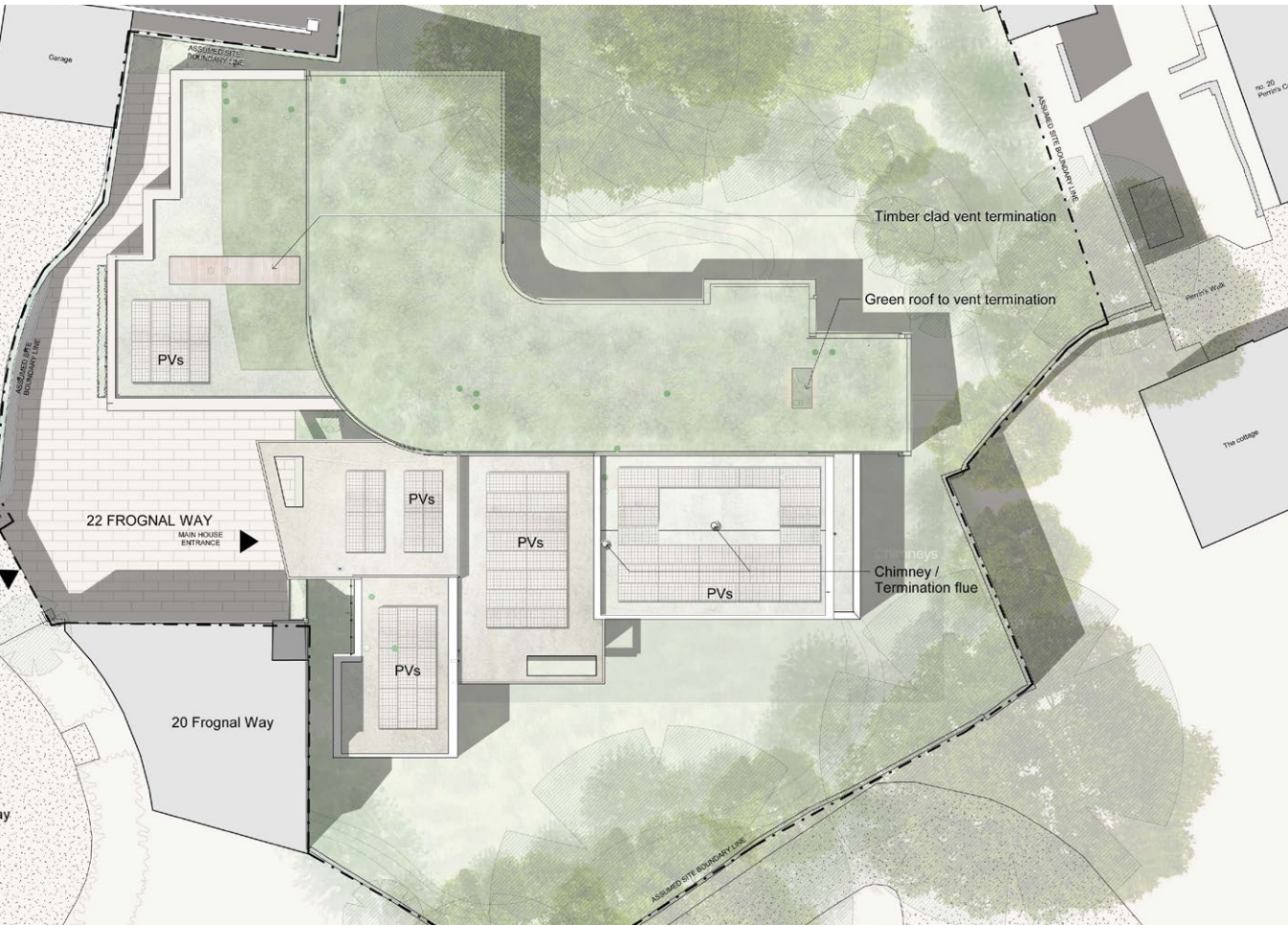

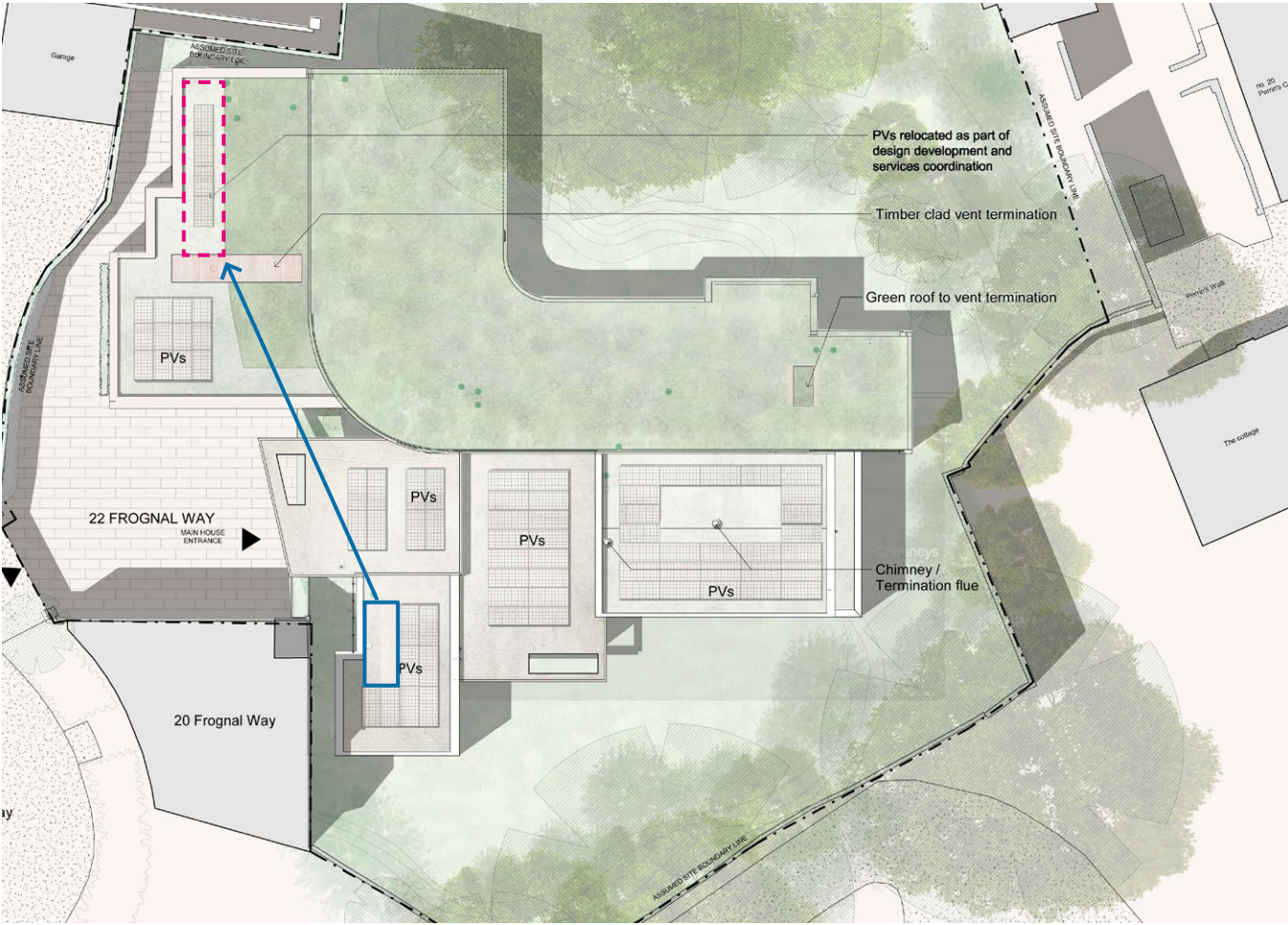
