T2: Bay: Front garden: Approximately 4.00m. Reduce up to 30%. General maintenance.
T3: Bay: Front garden: Reduce crown height by approximately 40-50%. Reduce lateral and sub lateral branch structure by approximately 20%. Raise crown by 0.50m. Reducing because of excessive shading.
T4: Bay: Right hand boundary: Reduce crown height by 30-40%. Reduce lateral and sub lateral branch structure by 20%. Too large for its location.
