I own the Grade 2 listed 179 King's Cross Road which is my family home.

I strongly object to the planned extension as it will have a very negative on my family and other residents in the neighbouring Grade 2 listed Georgian terraces.

- The taller building would cause loss of light and overshadowing of our rooms and
 gardens. Our garden decking area would be adjoined by a new high wall. Our
 quiet garden would be overlooked, overshadowed and so unpleasant that it will be
 unusable. The loss of use our gardens will have a very negative impact on our
 mental wellbeing.
- The use of the planned balconies that overlook our little gardens will cause lack of privacy and inevitable noise. The balconies will sit above our gardens and will overlook our bedrooms and bathroom. We have seating areas in our Field Place gardens which are used in a considerate way by our neighbours. I have great concern that being overlooked by balconies from another higher building in such proximity will put a stop to our privacy and the enjoyment of our gardens. Our bedroom will be overlooked by these balconies.
- Our visual amenity will be impacted due to the scale of the building. We will have altered views from our garden and balcony. The scale of the building is not in keeping with our smaller terraced houses. Our cityscape views will be altered and less charming.
- There will be noise and disturbance resulting from use of the balconies which
 overlook the rear of our houses and our gardens. Any noise from music, parties or
 even just talking will be amplified by bouncing off the rear walls. This will have a

negative effect on our sleep, ability to work from home and wellbeing.

The new extensions and balconies will loom over our Georgian terraces. The size
of the building is taller than any of its neighbours and has a negative effect on our
listed building and conservation area.

We urge the council to reject the proposal for these reasons and invite the applicant to resubmit the application without the extensions and new balconies.
