Hornbeam T1 (12M high, 350mm dia.) - Reduce the crown of the tree back to the most recent points of reduction (1.5 to 2 metres).

Reason: Close to frontage of property and causing excessive shading and loss of natural light.

Rear garden:

Leyland Cypress T2 (12M high, 500mm dia.) - Reduce height by 3 metres.

Ash T3 (18M high, 600mm dia.) - Reduce the height of the tree by up to 3 metres. Draw in lower crown laterals by 1 to 1.5 metres all around.
