T2: Oak (10m): Crown reduce to previous points removing 2m of re-growth to keep tree at a size suitable for its location
T3: Lime (12m): Re-pollard to previous points removing 2m of re-growth to keep tree at a size suitable for its location
T4: Plane (16m): Reduce on school side by 2m to rebalance after recent pruning works to hospital side
T5: Sycamore (18m): Crown reduce on school side by 3m to rebalance after recent pruning works to hospital side and remove major dead wood
