T1 London Plane x 1 (Platanus x Hispanica) This tree has outgrown its location and is blocking light from several properties and is restricting access to road and pavement.

Suggested works:

- Reduce all round by approx. 4-5m
- Thin crown by 20%

Rear garden

T2 Willow x 1 (Salix spp) To reduce weight to this leaning tree and improve light to gardens and properties.

Suggested works:

- Reduce all round by up to 6m

Rear neighbouring garden

T3 Lime x 1 (Tilia spp) To improve light and slow root expansion.

Suggested works:- Reduce all round to previous reduction
