I'm just looking at the above application, in particular condition 6 (details of motorised louvre system). I see that the application form notes the following:

*Condition no. 6*

*Submission of technical details of motorised blind in substitution of the motorised louvres previously approved via application 2016/1489/P.*

*The blind will be black-out and a radio transmitter which has a time clock radio transmitter built-in that allows to schedule the blind to close and open at certain times. The clock will therefore be set to activate at night.*

Please could you confirm by return email the time(s) at which the blind will be activated so that I have sufficient detail to discharge the condition. (e.g. if a neighbour was to complain about it not closing in the

evening, we need to have agreed a time at which it will close – which may be different in summer / winter etc.)
