T1: Pear: Approximately 11.00m. Reduce lateral and sub-lateral over extended branches by approximately 40% (2.00-2.50m). Reduce crown height by 30% (1.50m). Remove 1 x partially supported weak limb to the right hand of the crown when viewed from the garden. Reasons: The tree recently suffered major limb break out. There is decay at crown break. The tree has over extended branch structure and several weak limbs. The garden is used by residents and children.
