Proposal:

Alterations to existing entrance gate including increasing the height by 0.5m and other associated works.

Drawing Nos: A_104_PA 01; A_104_PA10; and Heritage, Design and Access Statement dated June 2021 prepared by Martin Edwards Architects.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless

otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans:

A_104_PA 01; A_104_PA10; and Heritage, Design and Access Statement dated June 2021 prepared by Martin Edwards Architects.

Reason:

For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 The application site is a grade II listed building in the Hampstead Conservation Area. The listing for the property includes the brick boundary wall and metalwork. The proposal seeks permission and listed building consent to make changes to the existing metal entrance gate including extending the existing gate by 0.5cm in height and upgrading works. The existing gate would be repositioned and the additional height created by adding 0.5m to the bottom of the gate. The upgrading would be minor and would include installing new hinges and a metal lock. The design and materials would remain the same although the lower portion of the gate would have additional vertical rods installed.

The gate is considered to have heritage significance. The proposed upgrading would retain majority of the fabric of the gate. Extending the gate in height still allows the gate to sit cohesively and comfortably within the boundary treatment retaining its visual character. The proposed alternations and upgrading are considered to preserve the gate's special architectural and historic interest and would not harm the significance of the grade II listed house or the Hampstead conservation area.

Due to the location and nature of the works, there would be no impact to neighbouring amenity by way of loss of outlook, daylight or privacy.

No objections were received prior to making this decision. The planning history of the site and surrounding area were taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building or its setting or any features of special architectural or historic interest which it possesses under s.66 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the

Planning (Listed Buildings and Conservation Areas Act) 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with policies of the London Plan 2021 and of the National Planning Policy Framework 2021.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.

5 Your proposals may be subject to control under the Party Wall etc Act 1996 which covers party wall matters, boundary walls and excavations near neighbouring buildings. You are advised to consult a suitably qualified and experienced Building Engineer.
