Re-Pollard Polpar tree (T1) back to previous it is in a small garden, low amenity value, is blocking lots of light to the surrounding gardens and lower trees. the tree is creating lots of shade in the garden and is growing into the house, over windows. The tree is also growing into the neighbours garden and blocking light for them as well.
