Reduce all aspects of the crown back to the most recent points of reduction, approximately 4m from branch tips.  
Retain shortened furnishing growth where possible for crown continuity

G1-Various

Reduce all overhang from neighbouring Cypresses and Bay back to the boundary line to improve clearance from the building

T2-Turkey Oak

Very tall and spindly crown, leaning towards neighbouring property.  
Suggested works are to reduce crown in height by 4-5m in height and 3m laterally to create a more compact framework for future crown management.

G2-Various

Reduce all overhanging growth from neighbouring limes back to the boundary line to improve clearance over garden
