Approx Crown Spread Diameter - 8m

Service - Crown Reduction

Work required- Crown reduce by removing 2m from the height and by removing 1-1.5m from the sides.

Reason - As per client's wishes, to manage size

Tree number - T3 & T4

Tree type - Sycamore (Acer pseudoplatanus)

Approx Height - 6m

Approx Spread - 2m

Location - See map

Service - Fell

Work required- Fell young sycamore trees as close to tree's current ground level as possible and leave the stumps in the ground. Treat stumps with glyphosate to prevent regrowth.

Reason - To prevent need for repeated pruning (fast growing species close to building)

Tree number - T5

Tree type - Cherry (Prunus Sp.)

Approx Height - 7m

Location - See map

Service - Prune

Work required- Crown lift branches over pavement to 3.5-4m from ground level.

Reason - To clear view of streetlights
