1 x Hornbeam (T4) - Reduce back to former reduction points.  
1 x Variegated Sycamore (T6) - Reduce back to former reduction points and trim lower Maple growth to give 5m clearance over the path.  
1 x Hornbeam (T7) - Reduce back to former reduction points.  
1 x Ash (T8) - Reduce back to former reduction points and trim lower growth to give 5m clearance over the path.
