Hillway Lime Avenue from Swains Lane to Holly Lodge Gardens:

83 Common Lime(previously reduced) - Reduce the crowns of the trees back to the most recent points of reduction (2 to 3 metres)

3 Common Lime(not previously reduced) - Raise crowns to 4 metres above verge ground level as required. Draw in sides of crowns where required by up to 2 metres.

1 Caucasian Lime, 1 Silver Pendant Lime and 1 Small Leaved Lime(none previously reduced) - Raise crowns to 4 metres above verge ground level as required. Draw in sides of crowns where required by up to 2 metres.
