Reduce lateral and sub lateral branches overhanging No.3 back to previous and most recent reduction points (2.00m-3.00m). Reduce remaining extraneous branches in higher crown back into main crown structure approximately 2.00-3.00m.

T2: Smaller Lime: Overhanging the boundary from No.1 North End Avenue: Raise Crown overhanging No.3 by 2.50-3.00m. Remove major dead wood throughout the crown. Thin crown density by approximately 20%.
