We would like to reduce the 2 large Horse Chestnut Trees in the front of the property by about 2-3 metres back to previous reduction points and thinning out the canopies by about 15%. This is for general maintenance as they haven't been done for some time, to increase light in to the properties and minimise root expansion due to proximity next to the flats.
