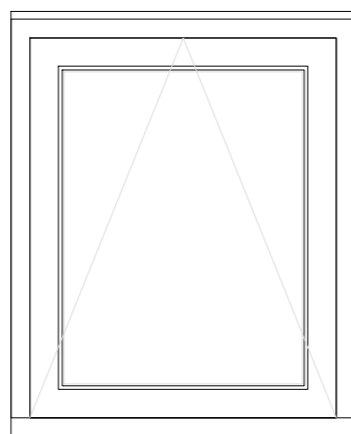

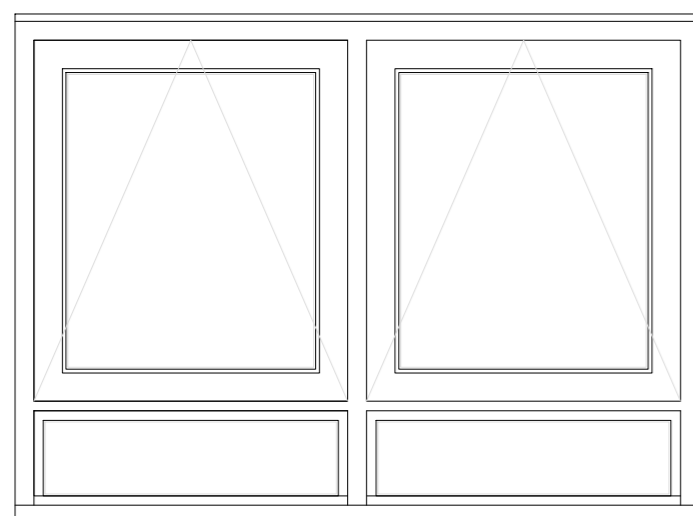
**2** EXISTING WIN. TYPE 5.

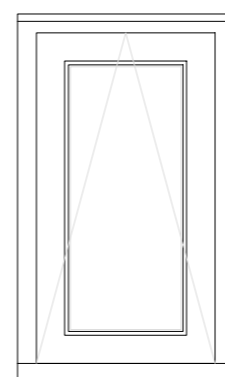
**EXISTING REAR ELEVATION**



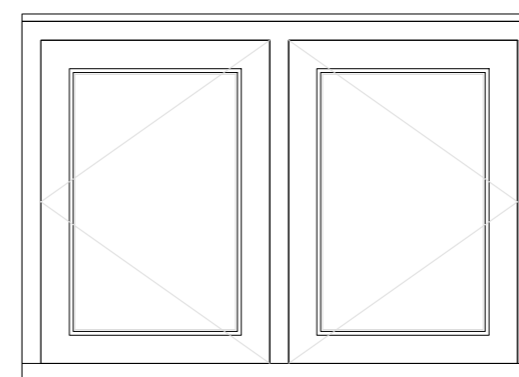
