All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: PL-000-Rev 2, PL-001-Rev 2, PL-100-Rev 0, PL-101-Rev 1, PL-200-Rev 1, PL-201-Rev 2, PL-300-Rev 1.

Reason: For the avoidance of doubt and in the interest of proper planning.

4 Reasons for granting permission.

The proposed changes to the façade are minor comprising: replacing and relocating the entrance door with new automated, sliding glazed doors. The proposal is not considered to have a detrimental impact on the appearance of the host building. The proposed design is considered appropriate and is

aligned with the existing, commercial character already established in the area and of the host building Euston Tower. Further to this the commercial aesthetic of the proposal is also considered appropriate as the application site lies within the Euston Knowledge Quarter and the Euston Business Improvement District. The proposal will not change the nature of the existing frontage which is active in line with the Euston Area Plan.

The proposal will not have a detrimental impact in In terms of neighbouring amenity.

No objections were received following statutory consultation. The site's planning history was taken into account when coming to this decision.

As such, the proposal is in general accordance with policies A1 and D1 of the Camden Local Plan 2017 and with the Euston Area Plan. The proposed development also accords with the policies of the London Plan 2021 and National Planning Policy Framework 2021

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraph 38 of the National Planning Policy Framework 2021.
