1.Lime x 4 (T1-T4) – Re-pollard the vertical growth. Retain and tie in lateral growth between trees. Retain but prune back lateral growth over the pavement.

Lime (T5) – Reduce crown by 1.5m on all aspects. Tie in lateral growth to adjacent trees.

Chinese privet (t6) – Fell. The tree is very close to the summer house. It's grown too leggy and with the adjacent limes it blocks too much light to the garden and summer house.
