#### Rear Garden:

- T1 Laurel Reduce height to agree level from photo approx 1.5m and trim right hand side back. Do not prune neighbours side.
- T2 Bay left hand side reduce back to previous reduction points by approx 2m. Trim Left Hand side neighbours side back towards fence retaining screening. Do not prune right hand side of bay.
- T3 Reduce Olive in height by approx 1-2m.
- T4 Pear tree Reduce left hand spread corner by approx 1.5m to form a rounded side deadwood.
