Reason: General maintenance.

T2: Willow Sapling - (self seeded): Fell to ground level and treat with systemic herbicide.

Reason: To allow for garden re-landscaping.

Rear Garden:

T3: Mature Elder: Fell to ground level and treat with systemic herbicide.

Reason: This tree is in poor condition and of low amenity value.

G2: Group of mixed species shrubs: Fell to ground level and treat with systemic herbicide.

Reason: To allow for garden re-landscaping.
