e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - Tree of Heaven - fell due to the damage that the tree is causing to the footpath leading up to the house and the damage the tree is causing to the front pillars. The tree is on the edge of the car park area and the footway and leans out over the car park area. The tree has been heavily reduced in the past and the new growth is forming but densely packed. Its likely that these will fail in the future and will require pruning again. This will reduce the impact and value of the tree. The proposal is to fell the tree and replant with a more suitable species.
