Proposal:

FRONT GARDEN: 1 x Ash (T1) - Reduce the tree back to the most recent reduction points whilst preserving a suitable amount of furnishing growth.

2 x Limes (T2 & T3) - Reduce back to the most recent reduction points, remove the heavy epicormic shoot regrowth.

1 x Beech (T4) - Thin the crown density by 25%. Remove extraneous branches back to the main crown structure.

1 x Hawthorn (T5) - Thin the crown density by 15%.
