e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We would like to reduce the 2 Leylandii trees at the bottom of the garden growing next to the neighbours property. Reducing them by about a third - 3-4 metres. The trees are growing very close to the neighbours property and there is concern that the roots may damage the foundations. They are also overshadowing the neighbours property, blocking out the light and filling the gutters with needles. Photos attached. The aim is to limit root expansion and bring more light in to the garden and neighbouring property.
