 Renovate shrub by removing approximately 50% of stems. Prune remaining stems as necessary with the objective to reduce size and enhance natural or desired form.
- Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to
- improve health and appearance and reduce risk of branch failure. Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown.

Most thinning cuts will be between 1 and 2 centimetres in diameter
