e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Prune T1 Bay located at the right side of property rear garden according to the following specifications:

- Renovate shrub by removing approximately 50% of stems. Prune remaining stems as necessary with the objective to reduce size and enhance natural or desired form.
  - Clean to remove all dead, diseased and broken branches 2 centimetres in diameter and larger throughout crown to improve health and appearance and reduce risk of branch failure.
  - Thin crown to remove approximately 10% of live branches to improve light and air penetration through crown.
- Most thinning cuts will be between 1 and 2 centimetres in diameter
