e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

We would like to reduce the Sycamore tree (T1) by about 2 metres and thin out the canopy by about 15% as the tree is overshadowing the garden. The neighbours gardens and houses at the back don't get much light either.

WE would like to reduce the small Cherry tree (T2) by about 2 m to allow more light through.

We would also like to reduce the lime tree by about 2-3 m and thinning the canopy by about 15%. This is because of the amount of shading it is doing to the garden and the neighbouring houses. The work would allow more light in to the gardens and neighbouring properties as the trees are growing in close proximity to the neighbouring property.
