I would like to share my views on why the area needs an Eruv which are listed below

- The Eruv will allow wheelchair users of all ages, who keep the Sabbath, to leave their home on Friday evenings
  and Saturdays. That means that they would be finally able to pursue social, leisure and educational activities
  as well as synagogue services.
- For many wheelchair users living on their own, especially the elderly, this may be the highlight of their week as the Eruv will allow them to go out to other social and leisure functions without infringing their religious beliefs.
- The Eruv will enable both parents who wish to keep the Sabbath and have young children to leave their homes
  on Friday evenings and Saturday to attend synagogue for both prayers and social functions on Friday evenings
  and Saturday and including all their children.
- The Eruv will facilitate access for Sabbath observant visitors to local hospitals and care homes, such as the
  Whittington Hospital and to the Royal Free Hospital and will allow them to bring necessary supplies and visit
  with their young children and families, on Friday evenings and Saturdays.
- The Eruv will facilitate the community more actively to extend its communal and social activities equally to all
  its members whilst avoiding infringement of Sabbath laws. This would greatly enrich the life of the community,
  as the Sabbath day is when the largest attendance of members in Synagogue services occurs.

- The Eruv will allow fuller use of the existing social, religious and community facilities provided by the local synagogue and other activities by ALL members of the community, without exception, in accordance with traditional Jewish law and thereby encouraging expansion of the range of these community activities.
- Other established Eruys, in Camden, Westminster, NW London, Woodside Park, Barnet, Edgware, Stanmore, Pinner, to name just a few, have already allowed higher levels of participation for young families including children in buggies and both their parents, as well as wheelchair users, in community activities -- be they social, leisure or religious.
- The Eruv will allow people to take with them at all times optional books, medication or other items they may need which are problematic where there is no eruv.
- The siting of the poles and wire in each location has been very carefully selected to minimise visual impact. Existing 'Eruvs' have shown that the poles and wire are virtually invisible once installed, merging as they do within the streetscape, and have to be positively pointed out in order to be noticed.
- Areas where an eruy has been installed have shown no change whatever in social cohesion, population trend or community relations - but have shown a huge benefit in the quality of life of those most concerned.
- Most of the areas surrounding Highgate and Muswell Hill already have Eruvs. This new Eruv therefore will not single out Highgate and Muswell Hill, but rather it will put our community on an equal footing with those around us, including for example Camden, Westminster, NW London, Woodside Park, Barnet, Edgware, Stanmore, Pinner.

I hope you can take these into account and we can move forward to finally having an Eruv in the area
