Lime x 3 (T1-T3) – Reduce crowns by 2-2.5m on all aspects. Remove epicormic and basal growth.

Beech (T4) – Prune back to previous most recent cuts (1-1.5m reduction). Thin crown by 15%.

The work will allow more light into all the adjacent properties in Tobin Close, and is part of cyclical pruning on the trees.
