T2: Cherry: Front Garden: Raise crown by approximately 0.50m. Reduce crown by approximately 1.00m all round. General maintenance.
T3: Magnolia: Reduce extraneous, overlong branches back into main crown structure. Reduce the crown by up to 1.50m. Thin crown density by 15%. Remove dead wood. Control encroachment over road and pavement.
2 x Ash Saplings: Growing within the front boundary hedge: Fell to ground level and treat with systemic herbicide. These trees should not be allowed to develop.
