T1Black Poplar x 1(Populus nigra) Very large previously pollarded tree, to maintain and improve light to several gardens and properties.

Suggested works:

- Reduce all round to previous reduction points approx. 8-10m
- Carry out aerial inspection of pollard points and report findings

Rear garden

T2Sycamore x 1(Acer pseudoplatanus) To maintain and improve light to gardens and property and slow root expansion.

Suggested works:- Reduce all round to previous reduction

points approx. 1-2m leaving furnishing

growth

Rear garden

T3Lime x 1(Tilia spp)To maintain and improve light to gardens and property and slow root expansion.

Suggested works:

- Reduce all round to previous reduction points approx. 1-2m leaving furnishing growth
- Remove epicormic growth

Rear garden

T4Common Crab Apple x 1(whiteb)To shape and maintain. - Suggested works:

- Remove overlong new growth back to previous reduction points approx. 2m

Rear garden

T5Rowan/Mountain (Sorbus Ash x 1aucuparia)To shape and contain and slow root expansion.

Suggested works: Reduce by approx. 1m
