T15 (Sycamore) - Fell to address risk of collapse. A replacement tree of a suitable species will be planted in a suitable location within the garden.

The tree has lost of between 30% and 40% of functional structural roots (majority of roots on southern and southwest aspects). Loss of vascular wood and cambium up to 1 m from ground on southern and southwest aspects with decay throughout this area extending in some locations, at least 100 mm into the stem of the tree. The physiological condition of the tree poor and it appears to be declining rapidly so the tree is unlikely to be adding sufficient structural wood and roots to mitigate fro the loss of structural strength in the base of its stem caused by the incipient decay in this area.

If the tree falls, it could impact people, buildings and vehicles.
